Notice and Procedure for Making Claims of Copyright Infringement Pursuant to the Digital Millennium Copyright Act.

The identification of the copyrighted work you claim has been infringed. (If you claim that multiple copyrighted works have been infringed you can submit one notification with a list of the allegedly infringed works.)

Identification of the material that you claim to be infringing and information reasonably sufficient to permit Forex Trading Authority to locate the material.

Information reasonably sufficient to permit Forex Trading Authority to contact you, including your address, telephone number, fax number and, if available, an electronic mail address.
